

INFORMATION NOTICE PURSUANT TO THE LEGISLATION GOVERNING THE PROTECTION OF PERSONAL DATA

Maglificio Giordano's srl (hereinafter called the "Company") provides this information notice pursuant to and for the purposes of article 13 of Regulation (EU) 2016/679 (hereinafter called the "GDPR"), relative to the protection of natural persons with regard to the processing of personal data, for the purpose of making you aware of the purposes of and arrangements for the processing of personal data that you may communicate while browsing in this website (hereinafter called the "Site"). It is clarified that this information notice refers solely to the Site and not to third party websites, which may possibly be reached by the User by means of links present in it.

CATEGORIES OF DATA PROCESSED

Browsing data

The IT systems and software procedures dedicated to the functioning of this website acquire, during the course of their normal exercise, some personal data the transmission of which is implicit in the use of the internet communication protocols. This concerns information which is not collected in order to be associated with identified data subjects, but which by their very nature may, by means of elaborations and associations with data held by third parties, permit users to be identified. Into this category of data fall, for example, IP addresses or the domain names of the computers used by the users which connect to the site, the addresses in URI (Uniform Resource Identifier) notation of the resources requested, the time of the request, the method used in submitting the request to the server, the dimension of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relative to the user's operating system and IT environment. This data will be used only for the purpose of obtaining anonymous statistical information on website use and to control its correct operation and are cancelled immediately after elaboration.

Data provided voluntarily by the User

The optional, explicit and voluntary sending of e-mail to the addresses indicated in the Site leads to the successive acquisition of the sender's address, necessary to respond to the requests, as well as any other personal data entered in the message. Furthermore, specific summary information notices shall be set out or viewed in the sections of the Site dedicated to particular services available upon request and submitted, where applicable, to the consent of the data subject.

Cookies

In accordance with the Guarantor Measure for personal data protection n. 229 of 8 May 2014, containing "Identification of the simplified means for information and the acquisition of consent to use cookies", **Maglificio Giordano's srl**, as personal data controller (hereinafter "Manager"), informs users about the use of cookies on this website (hereinafter "Site"). Please note that this information refers only to the Site and not to third-party websites, potentially reachable by the user through the link on it.

What are cookies

A cookie is a small file submitted to the browser in use and saved on your device when you visit a Site as maglificio-giordanos.com. Cookies allow efficient Site operation and improve its performance; they provide information for statistical or advertising purposes to the owner of the Site, mainly to personalise your web browsing experience, remembering your preferences. The Site only uses technical cookies - being browsing or session - and functionality cookies: these guarantee Web browsing and improve the usage; there is no need for users consent for their use. The Site does not use other types of cookies, neither for the communication of personal information nor for user tracking.

Technical cookies (session or browsing)	They guarantee normal browsing and use of the Site and their aim is to make browsing operational and optimal on the site.
Functionality cookies	They are strictly necessary to provide services explicitly required by the user.
First-party analytical cookies	They are used and created exclusively by Maglificio Giordano's srl , to collect information, in an aggregated and anonymous way, on the number of users and on how users visit the Site.
Third-party analytical cookies (e.g. Google Analytics)	Maglificio Giordano's srl has used suitable tools to ensure that processing with these cookies is performed purely for statistical purposes.

Most browsers are configured to accept, verify or possibly disable cookies through their settings. However, we remind you that disabling browsing or functional cookies may cause unsatisfactory Site functioning and/or restrict the service that we provide. PERIOD OF CONSERVATION OF DATA

The personal data collected by means of use of the Site is processed for the time strictly necessary to achieve the purposes for which it has been collected as well as, this latter having come to an end, for the timescales possibly established by current legislation. SCOPE OF COMMUNICATION OF DATA AND CATEGORIES OF ADDRESSEES

Exclusively for the purposes specified above, all the data collected and elaborated can be communicated to internal figures authorised to process it on action of the respective duties, as well as to external parties to which it should be necessary to communicate data. Such addressees, where they require to process data on behalf of the company, shall be designated as data processors with an appropriate contract or other legal deed. TRANSFER OF DATA TO A THIRD COUNTRY AND/OR AN INTERNATIONAL ORGANISATION

Your data will not be object of transfer to Third Countries outside Europe.

RIGHTS OF CONCERNED PARTIES

You have the right (see articles 15 -22 of GDPR) to ask our Company to access your data and to rectify it if it is inaccurate, to erase it, or to limit the processing thereof where the conditions are met, as well as to obtain the portability of the data provided by you only if object of automated processing based on consent or on the contract. Furthermore, you have the right to revoke the consent provided for the purposes of processing which require such consent, without prejudice to the lawfulness of the processing carried out up until the moment that the consent is revoked. You also have the right to make a complaint to the supervisory authority competent in the matter, that is the Italian Data Protection Authority.
